The small print. - Terms & Conditions

- The booking made is a contract between the nominated party leader (client) and Long Royd Ventures (LRV) who operate under the trading name of Chalet Le Tadore. All invoices and correspondence, and communication will be between the party leader and Long Royd Ventures.
- When a written confirmation is received by the client then a contract is entered into and confirms acceptance of the terms and conditions set out below.
- A deposit of 25% is required on confirmation of booking.

All bookings will be cancelled if the deposit is not received within 14 days.

The remainder to be paid 6 weeks prior to the commencement of the holiday. If the booking is taken less than 6 weeks then the full payment is required.

- A discount of 10% will be given when booking 2 or more weeks.
- A Security Deposit of £250 may be requested to cover any breakage's or damage and excessive cleaning costs. Lost and non-returned keys will be charged at £10 per key. This deposit is fully refundable, subject to any deductions on vacating the chalet.
- All brochure descriptions are made in good faith and every care taken to ensure their accuracy, but no liability will be accepted in the events of any error. All prices are correct at the time of printing. Once a final payment has been made the holiday price will not change.
- The chalet must only be occupied by the number of persons stated and rates are inclusive of linen and towels for the numbers stated at the time of booking.
- It will be understood that clients will arrange all their travel and be fully insured for the holiday and that LRV accept no responsibility for such.
- Unless previously agreed in writing, the holiday period is from Saturday to Saturday and the chalet will be available from 16:00 on the start date and must be vacated by 10:00 on the departure date
- If for any reason the booking needs to be cancelled by the client it must be done in writing and the following cancellation charges will apply:

Prior to 6 weeks	loss of deposit
6 - 4 weeks	50%
4 - 2 weeks	70%
Less than two weeks	100%

- LRV accept no responsibility for death, personal injury, accidents, loss or damage to persons or personal effects however caused unless resulting in negligence of LRV.

All necessary steps must be taken to protect all personal property. It is advised clients take out appropriate insurance.

- Force Majeure - LRV accepts no responsibility or liability whatsoever for any loss or damage or alteration to the terms of the booking caused by events beyond their control including but not limited to acts of God, war, act of foreign enemy, hostilities (whether war be declared or not), civil war, strife, invasion, rebellion, riot, commotion, disorder, malicious damage, fire, flood, tempest, epidemic, quarantine restriction, strikes and / or other industrial disputes, lockouts, freight embargoes, adverse weather conditions, shortage of raw materials or energy supplies, transportation delays and the failure of sub contractors or suppliers to perform.
